## **Parking Guidelines**

Please be aware that the curb is not to be used for daily parking. It can be used for an occasional short term visit, and the vehicle needs to be close to the curb for access to the fire lane.

We strongly encourage you to

## **Pet Policies**

Please keep you fur babies on a leash at all times, pick up poop every time they do their business. Even when you allow feces to pile up in your backyards it effects your neighbors and in fact is against your covenants. Be aware of when your pets are in your backyard or on your balcony, and do not allow them to disrupt the peaceful enjoyment of your neighbors with incessant barking or whining. While this may not affect your household it might have a negative affect on others around you.

Remember that all board meetings are

use your garage and driveway or 90<sup>th</sup> facing east. The fire lane is not to be parked in at any time, which is directly in front of the grassy areas/driveways of your homes. We ask to kindly tell all people that come and go from your home to refrain from blocking the fire lane. This area has been used by firetrucks and ambulances several times over the past couple of months and they have had to navigate illegally parked cars. This is unnecessary and dangerous.

Please inform all guests that visit your home of proper places to park to avoid issues and possible towing of vehicles or fines. A warning will be given and then a violation will be issued.
